## 1 Introduction

These program regulations govern the Master's degree program at the Faculty of Law of the University of Zurich (the Faculty).

They clarify and expand upon the Framework Ordinance (Rahmenverordnung or RVO) for Bachelor's and Master's Degree Programs and for Minor Study Programs at the Faculty of Law of the University of Zurich.

Further regulatory provisions are contained in the guidelines of the Faculty of Law at the University of Zurich on the transfer of credit toward a Master's degree, and on studying law as a minor subject at the Master's level (RLA M Law). In addition, the fact sheets published by the Faculty provide information on regulatory provisions.

An annotated course catalogue (Web VVZ) for each semester is published on the website of the Faculty of Law along with important messages and announcements for the semester in question.

Information concerning studies is also sent to students via their personal University e-mail account. Information is considered delivered as soon as it can be accessed from this e-mail account.

Students may not claim lack of knowledge of the content of a delivered e-mail, respectively of the communication form chosen by the Dean's Office, or of valid fact sheets.

## 2 Assessments

### 2.1 Notification of Assessment Method

The assessment method will be announced no later than four weeks prior to the end of the lecture period.

### 2.2 Examination Dates

Exams are held during two annual examination periods. Some modules have special examination dates; these are set by the instructors.

Examination dates will be announced no later than four weeks prior to the end of the lecture period.

### **2.3 Duration of Examinations**

Written examinations last at least one hour, oral examinations at least 15 minutes.

### **2.4 Master's Thesis**

Students must write a Master's thesis (one or more papers on topics covered by the Master's curriculum of the Faculty, work done in moot courts or Model United Nations, etc.) worth a total of 18 ECTS credits. The Master's thesis must receive a grade of 4.0 or higher.

The thesis (and all components thereof) is graded; the grade is taken into account in determining the overall grade of the Master's degree.

Papers must be written in German, unless the instructor allows the use of a different language or a paper in English is required.

Copying text more or less verbatim from the work of other authors without citing the source (plagiarism) and the repeated use of one's own work is prohibited. Such work will be returned with a failing grade.

## **3 Final Degree**

Master's degree candidates who have met all academic requirements of the program must submit a request for conferral of the degree of Master of Law.

The request must be submitted to the Dean's Office.

## **4 Switching to a Minor Study Program**

Students may switch from the Master's degree program to a minor study program within the Faculty provided no previous academic work or failed attempts bar the successful completion of the minor study program.

## 5 Core Elective Pool Common Subjects

The number of modules to be selected from the core elective pool depends on the chosen concentration.

## 6 Master of Law UZH

### 6.1 Content and Objectives

The degree program Master of Law UZH offers advanced study of various areas of law. As a Master's degree with no concentration, it is very flexible and can be applied to both a general orientation and to a specialized field.

### 6.2 Overview of Modules

The Master of Law UZH degree program has no compulsory modules. 12 ECTS credits must be earned from modules selected from the core elective pool Common Subjects. In addition, students must earn 60 ECTS credits from elective modules and 18 ECTS credits from papers or work in moot courts or Model United Nations.

#### Core Elective Pool Common Subjects

In accordance with Section 5, students must select two modules from the core elective pool Common Subjects.

#### Core Elective Pool Master's Thesis

Students must write a Master's thesis (one or more papers on topics covered by the Master's curriculum of the Faculty, work done in moot courts or Model United Nations, etc.) comprising a total of 18 ECTS credits. The Master's thesis must receive a grade of 4.0 or higher.

#### Elective Pool

60 ECTS credits must be earned from modules in the elective pool. In addition to the regular curriculum of the Master's degree program at the Faculty of Law, the elective pool includes modules offered in the study programs at the Bachelor's and Master's level at other UZH faculties as well as the Language Center of the University of Zurich and ETH Zurich. Credit earned from modules outside the faculty can be transferred toward the final degree at a total of 6 ECTS credits.

## **6a English-language Master of Law UZH**

### **6a.1 Content and Objective**

As part of the Bologna 2021 reform project in the Faculty of Law, the English-language Master's degree program International and Comparative Law will be introduced as of Fall Semester 2021. The English-language degree program will help to expand the offering in various areas of international and comparative law. The offering will include a large number of modules on public, private, and criminal aspects of international law, along with modules that take a comparative view. English-language modules have already been added to the Master's degree program for Fall Semester 2020. Starting from this semester, students will be able to complete a program of study entirely in English. In Fall Semester 2021, they will be transferred to the new degree program and will then be able to obtain a degree in International and Comparative Law. The new study program is available both to students with a Bachelor of Law from a Swiss university and students with a foreign university entrance qualification.

### **6a.2 Overview of the Modules**

The English-language degree program features a compulsory module worth six ECTS credits for students with a foreign university entrance qualification. All students must earn six ECTS credits by completing a module chosen from the Common Subjects core elective pool. In addition, students with a foreign university entrance qualification must earn 42 ECTS credits and students with a Bachelor of Law from a Swiss university 48 ECTS credits by completing modules from the International Law and Comparative Law core elective pools. Furthermore, students must earn 24 ECTS credits by completing elective modules and write one or several papers worth 12 ECTS credits.

Details of the two curricula will be published on the Faculty of Law website in due course.

## 7 Master of Law UZH with a Concentration in Legal Practice

### 7.1 Content and Objectives

The degree program Master of Law UZH with a Concentration in Legal Practice is designed to further strengthen and expand on the generalist education begun in the Bachelor's degree program; it is geared toward equipping graduates to work in private law practice, judiciary practice, etc. Course content strengthens knowledge of core areas gained in the Bachelor's program and includes practical application of knowledge in the areas of civil, criminal and/or public law, procedural law, and international law.

### 7.2 Overview of Modules

The degree program Master of Law UZH with a Concentration in Legal Practice has no compulsory modules. 54 ECTS credits must be earned from modules chosen from the four core elective pools (Common Subjects, Substantive Law, Procedural Law, and International Law). In addition, students must earn 18 ECTS credits from elective modules and 18 ECTS credits from papers or work done in moot courts or Model United Nations.

**Elective Pool**

18 ECTS credits must be earned from modules in the elective pool. In addition to the regular curriculum of the Master's degree program at the Faculty of Law, the elective pool includes modules offered in the study programs at the Bachelor's and Master's level at other UZH faculties as well as the Language Center of the University of Zurich and ETH Zurich. Credit earned from modules outside the faculty can be transferred toward the final degree at a total of 6 ECTS credits.

## 8 Master of Law UZH with a Concentration in Business Law

### 8.1 Content and Objectives

The degree program Master of Law UZH with a Concentration in Business Law offers advanced study of various areas of business law.

### 8.2 Admission

The requirement for admission is a case study or Bachelor's thesis in the area of commercial and business law; the case study and/or the thesis must have received a passing grade.

The module Financial Accounting (6 ECTS credits) offered by the Faculty of Economics, Business Administration and Information Technology at the University of Zurich, or an equivalent module, is a requirement of the Master's degree program. Please note that no credit is given toward the Master's degree for this module.

### 8.3 Overview of Modules

The degree program Master of Law UZH with a Concentration in Business Law has compulsory modules worth a total of 12 ECTS credits. 42 ECTS credits must be earned from modules chosen from four core elective pools (Common Subjects, Business Law Core Subjects, Other Business Law Subjects, Subjects in Economics). In addition, students must earn 18 ECTS credits from elective modules and 18 ECTS credits from papers or work done in moot courts or Model United Nations.

Credit earned from modules outside the faculty can be transferred toward the final degree at a total of 6 ECTS credits.

### 9.1 Content and Objectives

The degree program Master of Law UZH with a Concentration in Public Law offers advanced study (specialization) in various areas of public law, with an emphasis on international aspects of law (public international law, European law). This Master's degree program prepares students for positions in government institutions, public life, and international institutions.

### 9.2 Overview of Modules

The degree program Master of Law UZH with a Concentration in Public Law has no compulsory modules. 48 ECTS credits must be earned from three core elective pools (Common Subjects, Public Law, Public International Law and European Law). In addition, students must earn 24 ECTS credits from elective modules and 18 ECTS credits from papers or work done in moot courts or Model United Nations.

### Core Elective Pool Master's Thesis

Students must write a Master's thesis (one or more papers on topics covered in compulsory modules or the core elective pools Public Law or Public International Law and European Law, work done in moot courts or Model United Nations) comprising a total of 18 ECTS credits. The Master's thesis must receive a grade of 4.0 or higher.

### Elective Pool

24 ECTS credits must be earned from modules in the elective pool. In addition to the regular curriculum of the Master's degree program at the Faculty of Law, the elective pool includes modules offered in the study programs at the Bachelor's and Master's level at other UZH faculties as well as the Language Center of the University of Zurich and ETH Zurich. Credit earned from modules outside the faculty can be transferred toward the final degree at a total of 12 ECTS credits.

## **10 Entry into Force**

These Program Regulations are effective as of the 2013 fall semester.

They replace the Master of Law Program Regulations dated 28 May 2008, which are rescinded as of the fall semester 2013.
