"The Rules" Credits and Grading

- Credits: minimal grade required to receive credit points is 4.0*
 - Submission of a written comment and preparation of a presentation (+/- Bonus/Malus)
- Deadline: 23.59, Wednesday one week prior to the presentation date
 - Email to lst.heinemann@rwi.uzh.ch (you'll receive a confirmation of receipt)
 - Special rules for papers A D to allow sufficient time to write comment and presentation
- Grading: Comment/Presentation

- Comment (75%) and presentation slides (25%) Marks 1-6, 0.25-steps
- Oral presentation is not graded, but attendance is compulsory on the date of own subject
- Grading: Bonus/Malus for attendance
 - 11-14 (80-100%) = Grade +0.20
 - 5-10 (35-70%) = No consequences
 - 1-4 (10-30%) = Grade -0.20
 - Control: Weekly attendance list
 - Late hand-in of papers = fail
 - Absent on day of presentation = fail (Internships will not be treated in a privileged way)

* Papers with a grade below 4.0 (*not including* a potential Bonus) can be improved and readmitted to reach a maximum grade of 4.0. Universität Zürich

Material requirements for the comment

- No summary of commented paper
- Consultation of some further <u>academic</u> literature (see references to literature/links on the website)
- Concentration of comment on one or two core themes
- Constructive criticism on points requiring further-reaching analysis
- Application of the idea or theory developed by the author on a related question
- Development of an enhancement or a supplement to the analysis
- Analysis of weak points and strengths of the paper and/or suggestions for improvement

Formal requirements for the comment

- Scientific work (includes the proper use of references, particularly scientific Journals)
 - Page and chapter indications refer to books
 - Only references used in the text are to be quoted in the bibliography
- Approx. 1'500-2'000 words for Bachelor students, Approx. 2'500-3'000 words for Master students (papers not fulfilling this requirement will be refused for readmittance)
- Comparative reasoning
- Language: English
- Focus on a selection of arguments
- Semantics:
 - Don't use open questions: "Can this assumptions be made?"
 - Don't use empty phrases: "Only the future will tell..."

Requirements for the Presentations

- Short summary of the paper
- Use a maximum of 8-10 slides (incl. cover sheet & questions)
- Formal requirements: Powerpoint, approx. 10-15 minutes
- Visualise messages through graphics and images
- Explain the key issues of the article: What are the authors' messages?
- Comment on the authors' methods
- Explain the used key ideas
- If necessary, introduce referred articles or information
- Two questions for the discussion of your presentation (use the topics you discuss in your written comment)
